You can apply for your own ABN and register for GST for free on the ATO web site. The same with the clearance certificate every resident now needs to sell a property. There are electronic forms on the ATO website and it costs absolutely nothing to fill them out, nor are they complicated. But if you do a google search you will find sponsored sites offering this service. You may even think you are on the ATO web site, the questions are basically the same except of course for the request for credit card details.

If you are a resident of Australia for tax purposes, make sure you have a clearance certificate before you sell your property or the purchaser is required to withhold 15% of the purchase price and send to the ATO.
